Proposal Narrative

Lesbian, gay, bisexual, transgender, and queer (LGBTQ) studies is an interdisciplinary field that explores the artistic, cultural, economic, and political contributions of gender and sexually diverse individuals to their societies and the discrimination and violence suffered by gender and sexual minorities. LGBTQ studies scholars also document how different societies have treated gender and sexual diversity in the past. Under the guise of queer theory, LGBTQ studies challenges scholars and laypersons not to make value judgments about gender and sexual diversity. Drawing on developments from other disciplines, LGBTQ studies scholars recognize that same-sex sexualities differ across time and place. One particular contribution of LGBTQ studies has been to diagnose the economic, social, and political privilege afforded to heterosexual and gender-conforming persons, while concomitantly denigrating and punishing gender and sexually nonconforming persons.

Sexuality studies, particularly LGBTQ studies, is a research and teaching strength of the Department of Women's, Gender, and Sexuality Studies (WGSS) at the University of Cincinnati. This strength attracts M.A. students to our program. Faculty with appointments in WGSS who have expertise in LGBTQ studies include Ashley Currier, Amy C. Lind, Deborah T. Meem, and Carolyn Peterson; faculty with appointments outside of WGSS with expertise in LGBTQ studies include Michael Gott (Romance Languages and Literatures), John Maddux (English), Thérèse Migraine-George (Romance Languages and Literatures), Patricia Valladares-Ruiz (Romance Languages and Literatures), and Sarah Whitton (Psychology). I have enclosed statements of support for the purchase of this collection authored by Carolyn Peterson and Thérèse Migraine-George (supporting materials).

The "LGBT Thought and Culture" collection has brought together several disparate collections. First, the archive contains the Magnus Hirschfeld Collection, which consists of Hirschfeld's correspondence, publications, newspaper articles, and court documents related to the life of the noted German sexologist. Second, the collection acquired parts of the Kinsey Institute's archives, such as early transgender and transsexual movement documents and publications. Third, the collection contains materials related to LGBTQ and HIV/AIDS organizing in the U.S. Fourth, other publications include newspapers that serve African American and Latina/o LGBTQ communities. Although the collection is not exhaustive, it provides students and researchers with an important starting point for delving more deeply into LGBTQ history, culture, and politics.

Acquiring the LGBT Thought and Culture" collection would benefit faculty and students in WGSS and other departments in several ways. First, this resource constitutes a boon for students and faculty conducting research in the area of LGBTQ and sexuality studies. Many WGSS M.A. students have expressed interest in LGBTQ history, popular culture, and social movements in the U.S. and in other societies. For my own research, the collection would prove to be useful in a future research project examining the transnational diffusion of the "LGBT" acronym to other sources. I would be interested in using the collection to document the rise of the LGBT acronym in U.S. activist vocabulary and to identify contact U.S. LGBT activists had with LGBT activists in other countries. The "LGBT Thought and Culture" resource would provide students with primary and secondary sources they can use in their research. Such sources include films, novels, and original LGBTQ movement documents. Second, this resource would greatly enhance courses in LGBTQ and sexuality studies taught by WGSS faculty including Currier, Lind, Meem, and Peterson. For instance, in my graduate-level "WGS 8000: Feminist Research and Methods" course, I teach students about archival research and analyzing primary sources, such as personal narratives, newspaper articles, and original social movement documents. It would be a great advantage to turn to a collection of related documents to work with students on looking for connections among documents and how to analyze documents as a group. I also teach "LGBT Studies" and "Homophobias," courses in which personal narratives and other primary sources would enhance my ability to illustrate lived gender and sexual diversity and differences in LGBT organizing across time and cultures.

Budget Justification

I am requesting \$31,000 to cover the cost of acquiring "LGBT Thought and Culture." I quote from Sally Moffitt's letter of support for acquiring this collection because she explains the budget for this collection very well: "*LGBT Thought and Culture* is available from Alexander Street Press for a one-time purchase price of \$32,500. This price includes MARC records for all individual items in the database. Inclusion of MARC records increases the database's research value by providing access to each individual piece through author, title, subject, and keyword access in the library's catalog as well as through searching or browsing in the database itself. There is an ongoing hosting fee of \$250 that will be assessed starting in 2015. The library pays for the annual hosting fee in addition to the cost of adding all the MARC records and other cataloging expenses. The library also assumes the ongoing costs associated with maintain and servicing the database. In addition, the library can put forward \$1,500.00 from the general collection's allocation for acquiring women's gender and sexuality studies monographic materials by foregoing purchases of current publications in that amount during 2013-2014" (p. 2).

LGBT Thought and Culture database provides primary source documentation for teaching and research addressing both current LGBT political and social movements and their historical antecedents during the past 100 years of the 20th century. The material that forms the core of this database is widely scattered among various entities including research facilities such as the Kinsey Institute Archive and Library and the National Archives of Great Britain; local and national organizations such as ACT UP and National Gay and Lesbian Task Force; noted publishers of LGBT literature such as Lambda Publications and Seal Press; and the contents of important archival collections such as the Magnus Hirschfeld Collection and the Tracy Baim Editorial Files.

Types of resources brought together from these widely scattered repositories include literary works both published and in manuscript; letters, memoirs, biographies, and personal papers; professional correspondence and confidential reports of early sex researchers; speeches and interviews; seminal texts and ephemera. Because these resources are drawn from holdings in the United States, Latin America, Europe, Australia, and New Zealand they afford an unprecedented overview of the transnational nature of LGBT experience, thought, and culture.

LGBT Thought and Culture database offers guided searching by author, title, topic, and named archival collection contents in addition to free-text searching over the entire database contents. Playlists are a unique feature of this database, allowing researchers to create their own personal files of resources selected from the contents of the database. These playlists may be annotated, edited, and shared. Playlists may be used in-class as a teaching resource or may be assigned to students for out-of-class viewing. Each playlist that is created contains its own unique static URL.

WorldCat shows that as of this writing 9 university libraries have added *LGBT Thought and Culture* to their collections, none of which are in Ohio and the closest of which is at Northwestern University. The database is not among CRL's collections nor is it likely to be since for CRL to provide online access to its many member institutions is cost prohibitive. CRL continues to purchase microfilm and print collections, but does not purchase digital collections.

Acquisition of *LGBT Thought and Culture* will enhance and compliment a number of research collections in University Libraries, including these microfilm collections: *Atlanta Lesbian Feminist Alliance Archives, ca.* 1972-1994; *Lesbian Herstory Archives Subject Files;* National *Gay and Lesbian Task Force Records,* 1973-2000; *Selected Newsletters and Periodicals from the Holdings of the Gay, Lesbian, Bisexual Transgender History Society Parts* 1 through 3; *Selected Periodicals and Newsletters from the Holdings of the Gay, Lesbian, Bisexual, Transgender Historical Society;* Underground Newspaper Collection; Women and/in *Health/Women's History Research Center;* Women and Law; and the databases Women and *Social Movements in the United States* Scholar's Edition and Women and Social Movements *International.*
