I was also accepted to read a paper derived from this project in the SLLC Graduate Student Conference, University of Maryland, March 27 - 29; and I am waiting for a response from CUNY's and Asociación de Colombianistas' upcoming conferences.

III. Project Narrative: An Intersectional Approach to Colombia's La Violencia Literature: The Works of Soraya Juncal, Flor Romero, Fanny Buitrago, and Albalucía Ángel

Statement of Purpose

Latin American Literature is no stranger to the concept of *violence* in narrative. From the romantic novels of the 19th Century to the *Narco-novelas* of the 21st, with the essential phase of the 20th Century *Bananera Novel, violence* is a keystone of the narrative written in the Spanish-speaking regions of the Americas. Given the undeniable tradition of the topic, one might think that research in this field is completely jaded. However, today, when Colombian civil war is, apparently, coming to an end and when the whole country is endeavoring into rescue the memories lost from its culture, to recapture the narratives from its origins is imperative.

The genesis of the conflict, or at least of its current dynamic, is historically located in the death of Jorge Eliécer Gaitán, a liberal social-democrat leader, who embodied the paradigm of "the people's man", and was running with advantage in the presidential campaign of 1948. On April the 9th, the same year, he was killed near Bogota's Plaza de Bolívar, starting the biggest riot ever witnessed by the Colombian capital; a riot that, instead of decreasing as the years went by, became the starting point of a period known as *La Violencia* where liberals and conservatives started killing each other, just because the other praised either red or blue (their colors). *La Violencia* was politically settled in 1958, but its social consequences would remain among many Colombians who decided to start a guerrilla's war against the old oligarchy.

Many Colombian novelists from late 20th Century gave their personal perspectives of this conjuncture; they became the voices of *Literatura de la Violencia*, an all male, 'white', urbanite, and upper-middle class, group who spoke about Colombia's struggles with the polarization of its politics. A historical study of the specific causes to exclude women from this group is in order; the focus of this particular exploration is to regain a space in academia for a group of female authors who talked about *La Violencia* in their works. To achieve this purpose, I analyze the novels: *Jacinta and the Violence* (1967), by Soraya Juncal; *Fox's Tail* (1970), by Fanny Buitrago; *Crackling Tropic* (1972), by Flor Romero; and *The Red Bird Sitting on the Green Lemon* (1975), by Albalucía Ángel. These novels are devoted to portray the gradual decay of the country from the

perspective of a subordinate in a patriarchal society: the daughter, the wife/partner, and the countryside dweller as well as their condition of victims, witnesses, or accomplices in the facts of violence that surrounded them.

The project I am presenting here constitutes a keystone to my dissertation: it does not only provide a big portion of the socio-historical context where I will be locating the narratives I am studying; it also defines the hierarchy of 'intersectional values' (race/class/sex-gender/nationality) in the construction of a fictional text, with *La Violencia* as background, by Colombian women, which is what ultimately comprises my whole perception of the topic. Likewise, the expected outcomes of this project (see below) will grant significant feedback in the process of refining the results of my research.

The Role of the Proposed Project in my Degree Program

The topics I will deal with in the development of this project are already included in the dissertation prospectus I have been working on with Professor Patricia Valladares-Ruiz as my advisor. Therefore, its results will end up somehow making part of the whole research process; and even if they do not end up as an actual section of the thesis, they will certainly contribute to a more efficient debug of the raw material I will have to consider in it. With this advantage, it will be so much easier to start working directly on a final product rather than just improving the prospectus, in order to have a solid base to start with. Needless to say, this will enhance my possibilities of graduating by end of my fourth year at UC, as well as the opportunities to find a job for the next school year.

Current Status and Expected Outcomes of the Project

With the purpose of setting a historic framework of the events of *La Violencia*, I have selected the works: *Chronicle of Four Decades of Politics in Colombia* (Daniel Pécaut 2006), *Between Legitimacy and Violence: A History of Colombia*, 1875-2002 (Marco Palacios 2006), and *The Making of Modern Colombia: A Nation in Spite of Itself* (David Bushnell 1993). Likewise, an outline for the concept of violence as a literary object must be provided in order to establish linkages between the works in analysis and their context of production. For this particular matter I have consulted: *Violence and the Sacred* (René Girard 2005), *Masculine Domination* (Pierre Bourdieu 2002), and *Trauma: A Social Theory* (Alexander 2012). It is necessary to set a background for the literary tradition, *Literatura*

de la Violencia, where these works are circumscribed, thus the following sources have been subjected to analysis: Violence and Literature from Colombia (Tittler 1989), Violence and Marginality in Hispanic-American Literature (Osorio 2005), and Literature and Culture. Colombian Narrative From the 20th Century (Jaramillo et al. 2000). Finally, in order to ascertain a common ground between the complexities of the fictionalized stories, this research is methodologically guided by intersectional studies, with special focus on: Emergent Writing Methodologies in Feminist Studies (Livholts, ed. 2013), Gender in Modernism: New Geographies, Complex Intersections (Scott, ed. 2007), and Gender, Sexuality, and Power in Latin America since Independence (French, Bliss eds. 2006).

Expected outcomes: publishing <u>at least</u> one article on a peer-reviewed journal for Hispanic/Latin American literature inside the U.S; then, publishing a second article on a peer-reviewed, internationally indexed, journal in Latin America; finally, I will attend two conferences in Spring-Summer 2016, each with different papers from this project.

Specific Anticipated Impacts on One's Intellectual Development

From the academic perspective, *La Violencia* Literature has had several studies in Colombia as well as in the U.S. and Europe; nevertheless the names that are being considered here, as well as the linkages between text and context, and the Intersectional approach that will be used as theoretical support of the whole research will provide cutting-edge perspectives not only on studies about Colombia or its (Female) Literature, but also about society, politics and *violence* in general. The biggest difference of this research with previous studies about *La Violencia* Literature is its encompassing of the historical elements that narratives display, and their attribute of cultural products, with the goal of setting them as living memories in Colombia's post-conflict.
